

AN ACT TO ADD A NEW SECTION 15105 TO  
THE GOVERNMENT CODE OF GUAM RELATIVE  
TO THE FILLING OF VACANCIES IN THE  
POST OF WASHINGTON REPRESENTATIVE.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 15105 is hereby added to the Government  
3 Code of Guam to read as follows:

4 "Section 15105. Same. Vacancies. In the event  
5 of a vacancy in the position of Washington Repre-  
6 sentative, caused by the death, resignation, or  
7 incapacity of the incumbent, the Governor of Guam  
8 shall, with the advice and consent of the Legislature,  
9 appoint from among those qualified for such position,  
10 a person to serve until the next regular general  
11 election for members of the Guam Legislature, and  
12 until his successor has been qualified or the  
13 Congress of the United States provides for a  
14 Resident Commissioner or Delegate or Territorial  
15 Deputy for Guam, at which next regular general  
16 election, a special election shall be held to  
17 fill the vacancy in such position."

18 Section 2. This Act is an urgency measure.
