## AN ACT MAKING APPROPRIATIONS FOR MECESSARY CAPITAL IMPROVEMENTS AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The following sums are hereby appropriated, from any available funds in the Unappropriated Surplus of the General Fund, for the purposes set forth herein:

Section 2. The appropriations made by Section 1 of this Act shall be effective immediately and shall be available for all expenses incident to the purposes for which made. Every appropriation made herein shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 5. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the fiscal year beginning July 1, 1967, the sum of Twenty-Five Thomsand Dellars (\$25,000) to supplement the appropriation made by Section 1(b) of this Act.

Section 6.
