



AN ACT MAKING APPROPRIATIONS FOR NECESSARY  
CAPITAL IMPROVEMENTS AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The following sums are hereby appropriated, from any available funds in the Unappropriated Surplus of the General Fund, for the purposes set forth herein:

(a) Additional Classrooms	\$600,000.00
(b) College Construction (supplement P. L. 8-158)	120,000.00
(c) Workman's Compensation Fund	18,500.00

Section 2. The appropriations made by Section 1 of this Act shall be effective immediately and shall be available for all expenses incident to the purposes for which made. Every appropriation made herein shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 3. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the fiscal year beginning July 1, 1967, for the purposes set forth herein:

(a) Collateral Equipment for Classrooms	\$ 65,000.00
(b) Detention Home Construction	85,000.00

Section 4. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the fiscal year beginning July 1, 1967, the sum of Five Hundred Sixty Thousand Dollars (\$560,000) to supplement the appropriation made by Section 1(a) of this Act.

Section 5. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the fiscal year beginning July 1, 1967, the sum of Twenty-Five Thousand Dollars (\$25,000) to supplement the appropriation made by Section 1(b) of this Act.

1           Section 6. There is hereby appropriated from any available funds  
2 in the Unappropriated Surplus of the General Fund for the fiscal year  
3 beginning July 1, 1967, the sum of Fifty Thousand Dollars (\$50,000) for the  
4 purchase of furniture and furnishing for the new Guam Courthouse Building  
5 and to pay freight charges therefor, such appropriation to be under the  
6 control and direction of the Administrative Officer of the Courts of Guam.

7           Section 7. This Act is an urgency measure.
