AF ACT TO ADD SECTIONS 8803, 8904 AND 8805 TO THE GOVERNMENT CODE OF GUAL TO PROVIDE FOR THE GAINFUL EMPLOYMENT OF PRISON INMATRS.

BE IT ENACTED BY THE PEOPLE OF THE TERRIPORY OF GUAE:

Section 1. Section 8803 is hereby added to the Government Code of Guam to read as follows:

"Section 5805. Labor of immates. The Director of Public Safety is authorized to permit a prison immate who is confined for an offense other than felony to be employed on a voluntary basis. This authority shall be exercised under the following criteria and conditions:

- (a) Only immates who have demonstrated good behavior and some promise of being able to rehabilitate themselves by engaging in gainful employment shall be allowed to work under this provision;
- (t) The working hours of such inmates shall fall between the hours of 8 A.E. to 5 F.L. and such inmates shall continue to be confined during non-working hours;
- (c) The immates are to be restricted to the premises of their employer during working hours;
- (d) he eages to be paid said immater shall be the same as those paid to others for similar wors as the territory."

Section 3. Section 8805 is hereby added to the Government Code of Guam to read as follows:

Safety, subject to the approval and promulgation of the Governor by Executive Order, is authorized to make rules and regulations to govern the employment of immates in private enterprise. Such rules and regulations shall take into consideration the primary object of this program which is to rehabilitate the immate so that upon his release from custody he may return to society as a useful and contributing citisen."

Section 4. This act is an urgancy measure.
