AN ACT

An Act to repeal Section 4207 of the Government Code of Guam, and to Enact a new Section 4207 to provide that all employees of the Government of Guam with military service shall receive retirement credit therefor and to amend Subparagraph (c) of Section 4233 of the Government Code of Guam relative to Legislative retirement.

Be it enacted by the People of the Territory of Guam:

Section 1. Section 4207 of the Government Code of Guam is hereby repealed and a new Section 4207 is hereby enacted in its place to read as follows:

"Section 4207. Credit for service with Armed Forces. Prior service credit shall be granted any employee who served in the Armed Forces of the United States prior to his employment with the Government of Guam as though such service was rendered for the Government of Guam, provided the employee shall not be receiving a pension or annuity from the United States Government on account of such service or is eligible to receive such pension or annuity on account of such service.

An employee shall also be allowed credit for active service in the Armed Forces of the United States for a period not to exceed five (5) years in addition to any active service performed during a national emergency proclaimed by the President of the United States or during a national emergency or state of war declared by the Congress of the United States, provided the

employee entered such active service while employed by the Government of Guam and re-enters its service within the period of one (1) year following his discharge from the Armed Forces of the United States under conditions other than dishonorable. Provided, however, that any former employee who upon his discharge from the Armed Forces completes his education under the provisions of the various Acts of Congress extending educational benefits to veterans shall have six (6) months after completing such education to rejoin the service of the Government of Guam to obtain the retirement credit extended hereunder."

Section 2. Subparagraph (c) of Section 4233 of the Government Code of Guam is hereby amended to read as follows:

"(c) Any person who has served as a member of the Legislature or who shall hereafter serve as such a member shall be entitled to receive credit as prior service for all services rendered as a member of the Legislature or in any other department, division, or agency of the Government of Guam, or U.S. Government (including the Armed Forces of the United States), provided, that in order to obtain credit for such prior service as a member of the Legislature, a person shall pay within five years after January 1, 1966, an amount equal to One Hundred Fifty Dollars (\$150.00) for each year of service as member of the Legislature during the period of 1951 to 1966."

Section 3. This Act is an urgency measure.

Approved August 25, 1967.
