

AN ACT TO ADD SECTION 640b TO THE PENAL CODE OF  
GUAM TO PROHIBIT REFUSAL TO RELINQUISH PARTY  
LINES IN EMERGENCIES AND TO PROHIBIT SECURING  
PARTY LINES BY FALSELY CLAIMING EMERGENCIES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 640b is hereby added to the Penal Code of Guam  
3 to read as follows:

4 "Section 640b. Refusal to Relinquish Party Line; Fraudulently  
5 Obtaining of Party Line. Penalty. Every person who shall refuse  
6 to immediately relinquish a multi-party telephone line when informed  
7 that such party line is needed for an emergency call either to a fire  
8 department, or police department or for medical aid or ambulance  
9 services, and every person who shall secure the use of such a party  
10 line by falsely stating that such line is needed for an emergency  
11 call, shall be guilty of a misdemeanor, punishable by a fine not  
12 exceeding \$500 or by imprisonment not exceeding one year, or by both  
13 such fine and imprisonment."
