AN ACT TO ADD SECTION 11011 TO THE  
GOVERNMENT CODE OF GUAM TO RENAME  
THE EAST BARRIGADA ELEMENTARY SCHOOL  
THE "PEDRO C. LUJAN ELEMENTARY SCHOOL."

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 11011 is hereby added to the Government Code  
3 of Guam to read as follows:

4 "Section 11011. Pedro C. Lujan Elementary School. The  
5 elementary school heretofore known as the East Barrigada Elementary School  
6 is hereby renamed the 'Pedro C. Lujan Elementary School', to honor the  
7 late legislator and judge from Barrigada who served his community so effec-  
8 tively and for so many years, Judge Lujan having been a firm supporter of  
9 public education his entire adult life. In such ceremony as the Director  
10 deems appropriate, said school shall be so officially named, at which cere-  
11 mony a plaque, bearing the name, picture, and history of Judge Lujan shall  
12 be affixed at a suitable spot within the school."

13 Section 2. This Act is an urgency measure.
