**AN ACT TO ADD A NEW §77136 TO CHAPTER 77 OF  
10GCA RELATIVE TO AUTHORIZING A CONTINUING  
ANNUAL APPROPRIATION FOR THE COSTS OF THE  
ANNUAL PEACE OFFICERS' MEMORIAL CEREMONY.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Section 77136 is *added* to Chapter 77 of 10GCA to read as follows:

3

4 **§77136. Continuing Appropriation for Annual Peace Enforcement Officers'**  
5 **Memorial Ceremony.**

6 Beginning in fiscal year 2016, the sum of Five Thousand Dollars (\$5,000) is  
7 appropriated annually from the General Fund to the Guam Police Department for the  
8 costs of the *Annual Peace Enforcement Officers' Memorial Ceremony*. The funds  
9 appropriated herein are not subject to any transfer authority.
