AN ACT TO AMEND § 77112 OF ARTICLE 1, CHAPTER 77, DIVISION 2, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZED EVENTS AND ACTIVITIES AT PASEO STADIUM AND THE JOSE C. GUERRERO FIELD IN HAGÁTÑA, GUAM.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 **Section 1.** § 77112 of Article 1, Chapter 77, Division 2, Title 21, Guam
3 Code Annotated, is hereby *amended*, to read:

4 “§ 77112. Community Parks and Recreation Facilities: Control.

5 (a) The control, management, development and general minor
6 maintenance of areas classified as community parks and community recreation
7 facilities shall be vested in the Commissioner of the municipality or village in
8 which such area is located, in accordance with the provisions of 5 GCA
9 Government Operations, § 40113. The Parks Division and the Department of
10 Public Works are responsible for all necessary repairs, maintenance,
11 renovations and capital improvements in these areas other than those general
12 minor repair and maintenance functions for which the Commissioners are
13 responsible. The Parks Division and the Department of Public Works shall
14 consult with Commissioners on work done in their village.

15 (b) Notwithstanding any other provision of law, Paseo Stadium and the
16 Jose C. Guerrero Field in Hagåtña shall not be used for events and activities

1 unrelated to baseball and other sports on Guam. The Director of the
2 Department of Parks and Recreation, or his authorized designee, shall ensure
3 that all sports-related events and activities, as sanctioned by the department, do
4 not adversely affect the playing fields, facilities, and areas of Paseo Stadium
5 and the Jose C. Guerrero Field.”
