**AN ACT TO APPROPRIATE FUNDS FROM THE FISCAL  
YEAR 2014 HOTEL OCCUPANCY TAX (HOT) SURPLUS  
FUND TO THE GUAM VISITOR'S BUREAU.**

1        **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2        **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that there exists Three Million Five Hundred Thousand Dollars (\$3,500,000) in the  
4 Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for appropriation.

5        **Section 2. Appropriation.** Notwithstanding any provision of law, the  
6 sum of Two Hundred Thousand Dollars (**\$200,000**) is hereby appropriated from  
7 the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the Guam Visitor's  
8 Bureau for the improvement, refurbishment, restoration, repair and/or maintenance  
9 of one park or attraction per village including village murals. Notwithstanding  
10 the general provisions of § 30107.1, of Chapter 30, Title 11 GCA, this  
11 appropriation *shall* continue to be available until expended and is *not*  
12 subject to transfer or use for any other purpose.
