#### AN ACT TO AMEND §7134 OF CHAPTER 7 OF 16GCA TRANSPORTING RELATIVE TO FROM A PORT ENTRY TO DEALERS' LOTS.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

2 **Section 1.** Section 7103 of Chapter 7 of 16GCA is *amended* to read as follows:

# §7103. Exemptions.

- (1) Upon obtaining a special permit from the Director of Public Safety, a person 5 need not register a vehicle of a type required to be registered under this Title for the 6 purpose of: 7
  - (a) Moving or operating a vehicle not previously registered on arrival of the vehicle in Guam, from the port of entry to a dealer's or distributor's place of business to the owner's residence or to the place for registration of the vehicle.

(b) Moving or operating a vehicle not previously registered, from a dealer's or distributor's place of business to a place where essential parts of the vehicle are to be altered or supplied.

(e) (a) Transporting a vehicle upon a highway when no part of such vehicle is in contact with the highway.

1	(d) (b) Moving a vehicle, which has been disabled as the result of an accident,
2	for the purpose of repairs.

4	(e) (c) Moving or operating a vehicle for the purpose of dismantling or
5	wrecking it, and permanently removing it from the highways.

7	(f) (d) Moving or towing a vehicle which is not registered and is used off the
8	highway or roadway for recreational purposes.
9	(2) Notwithstanding any other provision of this Chapter, a vehicle dealer
10	licensed to do business on Guam may, without any permits, registrations, certificates
1 1	or fees; operate unregistered vehicles on public roads for the purpose of transporting
12	said vehicles from a port of entry to the dealer's inventory lot.
