AN ACT TO APPROPRIATE FUNDS FROM THE FISCAL YEAR 2014 HOTEL OCCUPANCY TAX (HOT) SURPLUS FUND TO THE GUAM VISITOR'S BUREAU.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that there exists One Million Five Hundred Fifty Thousand Dollars (\$1,550,000) in
4 the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for
5 appropriation.

6 **Section 2. Appropriation.** Notwithstanding any provision of law, the
7 sum of Four Hundred Thousand Dollars (\$400,000) is hereby appropriated from
8 the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the Guam Visitor's
9 Bureau for the Guam Football Association for the purpose of hosting, attending,
10 and participating in FIFA 2018 World Cup and AFC Asian Cup 2019 Preliminary
11 Joint Qualification matches. Notwithstanding the general provisions of §
12 30107.1, of Chapter 30, Title 11 GCA, this appropriation *shall* continue to be
13 available until expended and is *not* subject to transfer or use for any other
14 purpose.
