AN ACT TO APPROPRIATE THE SUM OF TWENTY FIVE THOUSAND DOLLARS (\$25,000.00) FROM THE **INITIAL SAVINGS REALIZED IN FISCAL YEAR 2015** PURSUANT TO PUBLIC LAW 33-060 TO **DEPARTMENT OF** ADMINISTRATION **FOR** THE FUNDING FALLEN PURPOSE OF THE HEROES MONUMENT TO BE ERECTED BY THE FALLEN HEROES OF THE PACIFIC FOUNDATION (GUAM).

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Appropriation. Notwithstanding any other provision of law,
- 3 the sum of twenty five thousand dollars (\$25,000.00) is hereby appropriated from
- 4 the initial savings realized in Fiscal year 2015 pursuant to Public Law 33-060 to
- 5 the Department of Administration (Department) for the purposes of funding the
- 6 construction of the fallen heroes monument at a designated public location
- 7 identified by the Fallen Heroes of the Pacific Foundation (Guam). The Department
- 8 shall work in collaboration with the Fallen Heroes of the Pacific Foundation
- 9 (Guam) in the release of such proceeds to ensure the timely completion of the
- 10 fallen heroes' monument.
- The appropriation in this Section *shall not* lapse and *shall* remain available
- 12 pursuant to this Act until fully expended.
