1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any other provision of law,
3 the sum of twenty five thousand dollars (\$25,000.00) is hereby appropriated from
4 the initial savings realized in Fiscal year 2015 pursuant to Public Law 33-060 to
5 the Department of Administration (Department) for the purposes of funding the
6 construction of the fallen heroes monument at a designated public location
7 identified by the Fallen Heroes of the Pacific Foundation (Guam). The Department
8 shall work in collaboration with the Fallen Heroes of the Pacific Foundation
9 (Guam) in the release of such proceeds to ensure the timely completion of the
10 fallen heroes' monument.

11 The appropriation in this Section *shall not* lapse and *shall* remain available
12 pursuant to this Act until fully expended.
