1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any other provision of law,
3 the sum of thirty-nine thousand dollars (\$39,000.00) is hereby appropriated from
4 the initial savings realized in Fiscal Year 2015 pursuant to Public Law 33-060, to
5 the *Talofof'fo'* Mayor's Office for the purposes of the repair and upgrades to the
6 *Talofof'fo'* baseball field.

7 The appropriation in this Section *shall not* lapse and *shall* remain available
8 pursuant to this Act until fully expended.
