#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 **Section 1. Appropriation.** Notwithstanding any other provision of law,
- 3 the sum of one hundred fifty thousand dollars (\$150,000.00) is hereby appropriated
- 4 from the initial savings realized in Fiscal Year 2015 pursuant to Public Law 33-060
- 5 to the Sinajaña Mayor's Office for the completion of the Open Air Gymnasium,
- 6 renovations and reconfiguration of the parking lot, building of a playground, and

- 8 The appropriation in this Section shall not lapse and shall remain available
