1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any other provision of law,
3 the sum of one hundred eighty-six thousand, four hundred fifty-four dollars and
4 eighty-five cents (\$186,454.85) is hereby appropriated from the initial savings
5 realized in Fiscal Year 2015 pursuant to Public Law 33-060, to the Department of
6 Administration for the purposes of Typhoon Halong overtime payments.

7 The appropriation in this Section *shall not* lapse and *shall* remain available
8 pursuant to this Act until fully expended.
