AN ACT TO AUTHORIZE I MAGA'LAHEN GUAHAN TO EXCHANGE **GOVERNMENT-OWNED** PROPERTY IN ASINAN, ORDOT-CHALAN PAGO, RESERVED FOR THE DEPARTMENT PUBLIC OF HEALTH AND SOCIAL SERVICES WITH GOVERNMENT-OWNED PROPERTY IN DEDEDO OWNED BY THE CHAMORRO LAND TRUST COMMISSION FOR THE PURPOSE OF CONSTRUCTING **EMERGENCY HOUSING SHELTERS.** 

#### **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds 3 that there is a need for emergency home shelters and the Guam Housing and Urban 4 Renewal Authority (GHURA) has secured funding for this project through the 5 United States Department of Housing and Urban Development. I Liheslaturan Guåhan further finds that currently there exists certain government of Guam lands 6 7 that have been reserved for the use of the Department of Public Health and Social 8 Services for the construction of certain facilities; including a homeless shelter in 9 Asinan, Ordot-Chalan Pago.

*I Liheslaturan Guahan* finds that a more suitable parcel of property located
 adjacent to the Northern Regional Health Center and GHURA housing in Dededo is
 currently undeveloped and within the inventory of the Chamorro Land Trust
 Commission.

*I Liheslaturan Guahan* further finds that the Dededo location for emergency
 home shelters is highly suitable due to its proximity to health care facilities, public

transportation, grocery facilities, as well as government agencies that can manage
 the operation of these facilities.

Section 2. Land Exchange Authorized. Notwithstanding any other
provisions of law, and in consideration of the highest and best use of the properties
in question, *I Maga'lahen Guåhan* is hereby authorized to exchange two (2) acres
reserved for the Department of Public Health and Social Services Homeless Shelter
pursuant to P.L. 22-18, from the real property described as:

Lot No. 3470, containing an area of one hundred seventeen point nine four
three (117.943) acres, more or less, located in Asinan, in the municipality of
Ordot-Chalan Pago, as marked and designated on L.M. Checked No.
161FY93, and Department of Land Management Document No. 486438,
dated March 1993, a copy of which is attached as Exhibit A.


13 With the Chamorro Land Trust Commission real property described as:

Checked No. 074-FY2013, dated Semtember 2013, a copy of which is attached as Exhibit B.

Section 3. Waiver of Appraisal Requirement. Title 2, Guam Code
 Annotated, §2107 (b) requiring two (2) appraisals for any transfer of land or leasing
 of land before any consideration by *I Liheslatura* shall not apply to this Act.

22 Section 4. Effective Date. The provisions contained herein shall be 23 effective upon enactment of this Act.
