# AN ACT RELATIVE TO THE DEMOLITION OF THE MANUEL F. L. GUERRERO ADMINISTRATION BUILDING IN *HAGÅTÑA*.

# **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Legislative Findings and Intent. *I Liheslaturan Guahan* finds that §79601
of Article 6, Chapter 79, Title 21, Guam Code Annotated, the "Guam Capitol District," states
the following:

The Guam Capitol District is hereby established, consisting of the grounds and structures
comprising the old Guam Congress Building (the old legislative building), Skinner Plaza, *Plaza de España*, the Manuel F.L. Guerrero Administration Building and, upon the termination or
expiration of any leases attached to the property, the Post Office in *Hagåtña*. Properties included
in the Guam Capitol are hereby placed under the control and supervision of *I Liheslaturan Guahan*."

*I Liheslaturan Guahan* further finds the Manuel F.L. Guerrero Administration Building was constructed in the 1950s and while the facility has served its purpose, is now over sixty (60) years old and has serious structural, mechanical, electrical, and environmental issues that create significant safety hazards and render the building unfit for further occupancy such that all government of Guam agencies that were utilizing the building have relocated to other office facilities. The cost of rehabilitation to bring the building to current Uniform Building Code
 standards does not warrant the significant investment of public funds necessary to extend the
 useful life of the facility.

4 Section 2. § 79601 of Article 6, Chapter 79, Title 21, Guam Code Annotated is amended
5 to read:

§ 79601. The Guam Capitol District is hereby established, consisting of the grounds and
structures comprising the old Guam Congress Building (the old legislative building), Skinner
Plaza, *Plaza de España*, and, upon the termination or expiration of any leases attached to the
property, the Post Office in *Hagåtña*. Properties included in the Guam Capitol are hereby placed
under the control and supervision of *I Liheslaturan Guahan*.

# Section 3. A new §1515(i)(2)(B)(v) is hereby *added* to Article 5, Chapter 1, Title 5, Guam Code Annotated (HOT Bond Law) to read:

13 (B) for various projects related to Historic *Hagåtña* to include the following:

- 14 (i) for the restoration of the walls of the *Plaza de España*;
- 15 (ii) for the restoration and rehabilitation of the *Plaza de España Azotea*;
- 16 (iii) for the restoration of the *Plaza de España* Chocolate House; and
- 17 (iv) for the development of a paver-surface crosswalk and landings on both sides
- 18 of Marine Corps Drive to provide a proper connection between Skinner Plaza and the Chamorro
- 19 Village; and
- 20 (v) for demolition of the Manuel F.L. Guerrero Administration Building.
