1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Continuing Appropriation of the Controlled Substances**  
3 **Diversion Fund.** Notwithstanding Section 13 of Chapter XII of Public Law 32-  
4 181 or any other law, the unexpended balance of funds appropriated to the  
5 Controlled Substances Diversion Fund, *shall* not lapse and *shall* continue to be  
6 available for expenditures in Fiscal Year 2015 to procure training, investigative  
7 tools, and other items and services to support the Controlled Substances Program  
8 and Prescription Drug Monitoring Program, administered by the Division of  
9 Environmental Health of the Department of Public Health and Social Services, to  
10 combat the diversion of pharmaceutical controlled substances.
