AN ACT TO AUTHORIZE THE CONTINUING APPROPRIATION OF THE UNEXPENDED BALANCE OF FUNDS APPROPRIATED TO THE CONTROLLED SUBSTANCES DIVERSION FUND.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. **Continuing Appropriation of the Controlled Substances** 3 Diversion Fund. Notwithstanding Section 13 of Chapter XII of Public Law 32-4 181 or any other law, the unexpended balance of funds appropriated to the 5 Controlled Substances Diversion Fund, shall not lapse and shall continue to be 6 available for expenditures in Fiscal Year 2015 to procure training, investigative tools, and other items and services to support the Controlled Substances Program 7 and Prescription Drug Monitoring Program, administered by the Division of 8 9 Environmental Health of the Department of Public Health and Social Services, to combat the diversion of pharmaceutical controlled substances. 10
