**AN ACT TO AUTHORIZE THE CONTINUING
APPROPRIATION OF THE UNEXPENDED BALANCE
OF FUNDS APPROPRIATED TO THE
ENVIRONMENTAL HEALTH FUND FOR FISCAL
YEAR 2009 AND THE ENVIRONMENTAL HEALTH
FUND FOR FISCAL YEAR 2010.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Continuing Appropriation of the Environmental Health**
3 **Fund Fiscal for Year 2009 and Environmental Health Fund for Fiscal Year**
4 **2010.** Notwithstanding Section 13 of Chapter XII of Public Law 32-181 or any
5 other law, the unexpended balance of funds appropriated to the Environmental
6 Health Fund for Fiscal Year 2009 and the Environmental Health Fund for Fiscal
7 Year 2010, *shall* not lapse and *shall* continue to be available for expenditures in
8 Fiscal Year 2015 to procure lab equipment and materials, office furniture, field
9 instruments, and other items and services to support the operation of the Guam
10 Environmental Public Health Laboratory and other programs of the Division of
11 Environmental Health of the Department of Public Health and Social Services.
