Dear Madam Speaker,

Enclosed is Bill No. 174 -32 (LS), *An Act Making Appropriations for Medical and Dental Insurance Premiums for Employees of the Executive and Legislative Branches and for Retirees of the Government of Guam for Fiscal Year Ending September 30, 2014*, which I have **vetoed** and am returning with the objections that I outline below.

The supposed motivation behind Bill No. 174 was to save the government money, even if it resulted in the lack of choice. This was stated very clearly in the introduced version of Bill No. 174, and repeatedly in published columns and news interviews. However, this is far from accurate, and I must correct the misinformation given to the public about a supposed "\$18 million in savings," which some senators have been talking about with reference to Bill No. 174. Even under the most optimistic of scenarios, the savings in the bill would not result in \$18 million ready for appropriation from the General Fund. The initial projection was obviously overstated. The budget chairman, who initially relied on this projected savings to reduce the amount appropriated to cover the retirees' insurance pool in his original version of the budget bill, Bill No. 177, later realized that taking the projected savings from the retirees' insurance pool placed their coverage at risk, so even he had to restore the amounts that were supposedly saved in his second-to-last version of the budget, Bill No. 177.

Relying solely on last year's configuration of the plans selected by the GovGuam employees, at best there is a possibility of a projected savings of \$2 million by accepting an exclusive provider. However, this savings would come at the loss of choice to our employees, and it is tenuous at best. Even though one might assume that giving one health insurance company the exclusive contract would produce greater savings, the simple fact is that neither the Legislature nor the administration can predict the price, or even the estimated price, of the health insurance pool. The employees' and retirees' decision on whether to choose the more expensive 1500 deductible plan or the cheaper 2000 deductible plan, more than anything else, will determine the cost of the contract. And that won't be known until after open enrollment.

Stating that there will be any savings to the General Fund based on *one* of several possible scenarios is fiscally irresponsible at best. In addition, this single scenario ignores the obvious implications that the timing of the Medicare open enrollment will have on such savings:

- There has not been any information provided to substantiate the supposed savings in premium reduction due to GovGuam retirees opting to leave the GovGuam plan and join the Medicare Part D and Medicare Part D supplement. The cost to reimburse retirees for their purchase of these programs has not been presented. The cost GovGuam has to pay for 100% of the Medicare Supplement Plan F has also not been presented.
- Federal Open Enrollment to join Medicare is during November for coverage effective January 1, 2014. *Who will cover the drug expenses of the retirees during the 3-month period they opt out of GovGuam's health plan and prior to them joining Medicare Part D?*
- Who will cover any dependents of GovGuam retirees who would not be covered after the retiree opts out of GovGuam health insurance?
- What will be the Medicare Part D cost for retirees currently covered under the "Unqualified" prescription Drug Plan of GovGuam which is the 2000 Deductible Plan? They will have to pay the premium penalty for each year they failed to previously have coverage under a "Qualified" Drug Plan.

In order to realize an estimated savings of \$18 million, the bid for an exclusive contract would necessarily have to have come in at more than \$2 million below the actual amount projected to be paid out in total claims for FY 2013.

- Have the senators considered that an exclusive contract comes with a participating agreement that would have stipulated that this one insurance company had *the right to recoup its losses in the following plan year*, negating any "savings" there may have been? The multiple carrier contracts do not have such a provision.
- Have the senators considered the procurement nightmare that would happen should the company awarded the exclusive contract purposely bid below claims data for Fiscal Year 2015 so it could outright win the next contract and recoup revenues through the provisions of the participating agreement? This is a scheme that could have taxpayers paying where senators suggested there could be a "savings."

- Have the senators examined the risk that choosing an exclusive contract means that GovGuam employees and retirees and their dependents could be at the mercy of a company that, hypothetically speaking, could:
 - Try to pull out of the contract and yank insurance coverage in the middle of the year, potentially leaving our employees and retirees without any coverage to fall back on?
 - Deny coverage to employees and retirees when they need coverage most?
 - Bury what rightfully should be paid to employees and retirees in medical loss ratio rebates under a loophole and later pay these revenues as dividends to stockholders?
 - Fail to meet the needs of thousands of employees, retirees and their dependents simply because major clinics and medical centers do not recognize the insurance coverage?
- Have the senators considered the risk that forcing a change from the non-exclusive option to the exclusive one could trigger a protest that would cause the current contract to roll over? This would be the ultimate injustice to our employees and retirees, as the new plan year benefits are better for them, especially those needing expensive specialty drugs to treat their chronic diseases.

Rather than economic, the real motivation here appears to be more political. Are the senators who, for the past three years, have been advocating for employees and retirees to have choice in insurance carriers no matter the cost now changing their minds in support of one insurance company? What has changed so quickly in the minds and convictions of those who even used the issue of a single insurance carrier against me politically?

The responsible action we can take is two-fold. First, we should be consistent in our stated agenda to provide our employees and retirees with choice in health insurance coverage. Second, we should wait to know which plans the employees and retirees choose after open enrollment closes so we can know the true amount of savings to the General Fund. Then, and not before then, should we be able to responsibly estimate what can be appropriated from whatever savings there may be. Otherwise, we simply would be making empty promises to the taxpayers of Guam, and the employees and retirees who serve with us.





1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Government of Guam Health Insurance Program**
3 **Appropriation.**

4 (a) The sum of Five Million Seven Hundred Four Thousand Five
5 Hundred Seventy Nine Dollars (**\$5,704,579**) is appropriated for medical and dental

1 insurance premiums for fiscal year ending September 30, 2014 for the following
2 agencies: Office of *I Maga'låhen Guåhan* (GOV), Commission on Decolonization
3 (COD), Guam Ancestral Lands Commission (GALC), Veterans Affairs Office
4 (VAO), Bureau of Budget and Management Research (BBMR), Civil Service
5 Commission (CSC), Department of Administration (DOA), Guam Election
6 Commission (GEC), Department of Revenue and Taxation (DRT), Bureau of
7 Statistics and Plans (BSP), Department of Public Works (DPW), Contractors
8 License Board (CLB), Guam Board of Registration for Professional Engineers,
9 Architects and Land Surveyors (PEALS), Guam Police Department (GPD),
10 Department of Corrections (DOC), Department of Agriculture (AGR), Guam
11 Public Library System (GPLS), Department of Youth Affairs (DYA), Guam
12 Environmental Protection Agency (GEPA), Department of Labor (DOL),
13 Department of Parks and Recreation (DPR), Department of Land Management
14 (DLM), Office of the Chief Medical Examiner (CME), Customs and Quarantine
15 Agency (CQA), Department of *Chamorro* Affairs (DCA), Department of Military
16 Affairs (DMA), Guam Council on the Arts and Humanities Agency (CAHA),

22 Six Dollars (**\$16,625,546**) is appropriated from the Fiscal Year 2014 General Fund

9 active employee and retiree subscriber counts by plan by class by groups
10 supported/paid by autonomous agencies of the government of Guam,
11 detailed by autonomous agency.

12 (2) Autonomous agencies within this Subsection *shall* include the
13 Guam Power Authority, the Guam Waterworks Authority, the Jose D. Leon
14 Guerrero Commercial Port, the A.B. Won Pat International Airport
15 Authority, the Guam Housing Corporation, the Guam Economic
16 Development Authority, the Government of Guam Retirement Fund, and the
17 Guam Visitors Bureau.

18 (3) This report and corresponding Microsoft Excel file *shall* be
19 filed with *I Maga'låhen Guåhan* and the Speaker of *I Liheslaturan Guåhan*
20 *no later than* twenty (20) days after the end of each month of Fiscal Year
21 2014.

22 (b) All health insurance carriers for the government of Guam *shall* file a
23 monthly written report detailing each individual health insurance premium
24 payment received by the government of Guam health insurance carrier from the
25 government of Guam, by date and by agency to *I Liheslaturan Guåhan no later*
26 *than* twenty (20) days after the end of each month of Fiscal Year 2014.

1 **Section 4. Severability.** If any provision of this Act or its application to
2 any person or circumstance is held invalid, the invalidity *shall not* affect other
3 provisions or applications of this Act which can be given effect without the invalid
4 provision or application and to this end the provisions of this Act are severable.

Re: Request to Waive Public Hearing

Hafa Adai Speaker Won Pat,

A memo identified as HRD No. OG-13-727 was sent to the Legislature, from the Government of Guam Health Insurance Negotiating Team identifying two options for medical and dental coverage for the government of Guam employees, retirees and their families. In light of the recent veto by the Governor of Substitute Bill 38, a contract for FY2014 health insurance might be entered into prior to the passage of the FY2014 Budget Act.

Public law requires that the most economical and beneficial health insurance plan be selected for the government of Guam employees, retirees and their families. Bill No. 174-32 (LS) will provide the appropriate funding to enter into such a contract.

I hereby request that the public hearing for Bill No. 174-32 (LS) "An Act making Appropriations for Medical and Dental Insurance Premiums for employees of the Executive and Legislative Branches and for Retirees of the Government of Guam for Fiscal Year ending September 30, 2014" be waived pursuant to Section 6.04 of the *I Mina'trentai Dos na Liheslaturan Guahan* Standing Rules and Section 2103 of Title 2 Guam Code Annotated. It is critical that the Legislature act quickly to ensure that the government of Guam promptly funds health insurance for FY2014 in order that appropriate contracts for employees' and retirees' health insurance are adequately funded and certified. Funding the most economical and beneficial health plan for the government of Guam health insurance program will ensure that other critical government operations, including health, education and public safety, be preserved for FY2014 pending the enactment of a budget bill.

3 that the selection of the healthcare insurance plan for the government of Guam
4 employees and retirees by *I Maga'låhen Guåhan* shall represent the most
5 economical and beneficial healthcare insurance proposal. *I Liheslaturan Guåhan*
6 further finds that *I Maga'låhen Guåhan's* selection and intent to contract with the
7 non-exclusive healthcare insurance proposal for government of Guam employees
8 and retirees is not the most economical and beneficial healthcare insurance plan
9 according to the HRD. No . OG-13727 Memo submitted to *I Liheslaturan Guåhan*
10 from the Government of Guam Health Insurance Negotiating Team, as the
11 exclusive healthcare insurance proposal offered government of Guam savings of
12 Eighteen Million Seven Hundred Seventy Four Thousand Eight Hundred Sixty
13 Dollars (**\$18,774,860**) as compared to the non-exclusive healthcare insurance

1 proposal savings of approximately One Million Sixty Thousand Six Hundred
2 Eighty Four Dollars (**\$1,060,684**).

3 *I Liheslaturan Guåhan* further finds that such decision made by *I*
4 *Maga'låhen Guåhan* represents an injustice to the government of Guam employees
5 and retirees as well as to the taxpayers of Guam such that *I Maga'låhen Guåhan's*
6 decision to contract with the non-exclusive healthcare insurance proposal costs
7 employees, retirees and all taxpayers almost seventeen (17) times more than if *I*
8 *Maga'låhen Guåhan* decided to contract with the exclusive healthcare insurance
9 proposal.

10 It is the intent of *I Liheslaturan Guåhan* that the government of Guam
11 employees and retirees are provided the most economical and beneficial healthcare
12 insurance plan that can be negotiated by the Government of Guam Health
13 Insurance Negotiating Team for Medical and Dental Insurance for Fiscal Year
14 2014 and to prevent *I Maga'låhen Guåhan* from making decisions based on other
15 criteria moving forward. Furthermore, it is the intent of *I Liheslaturan Guåhan* that
16 these additional savings from selecting an exclusive contract for healthcare
17 insurance for government of Guam employees and retirees may be directed toward
18 government operations such as education, health, and public safety as well as for
19 Hay Study pay increases and Cost of Living Allowances for government of Guam
20 retirees.

21 **Section 2. Government of Guam Health Insurance Program**
22 **Appropriation.**

23 (a) The sum of Five Million Seven Hundred Four Thousand Five
24 Hundred Seventy Nine Dollars (**\$5,704,579**) is appropriated for medical and dental
25 insurance premiums for fiscal year ending September 30, 2014 for the following
26 agencies: Office of *I Maga'låhen Guåhan* (GOV), Commission on Decolonization
27 (COD), Guam Ancestral Lands Commission (GALC), Veterans Affairs Office

1 (VAO), Bureau of Budget and Management Research (BBMR), Civil Service
 2 Commission (CSC), Department of Administration (DOA), Guam Election
 3 Commission (GEC), Department of Revenue and Taxation (DRT), Bureau of
 4 Statistics and Plans (BSP), Department of Public Works (DPW), Contractors
 5 License Board (CLB), Guam Board of Registration for Professional Engineers
 6 (PEALS), Architects and Land Surveyors, Guam Police Department (GPD),
 7 Department of Corrections (DOC), Department of Agriculture (AGR), Guam
 8 Public Library System (GPLS), Department of Youth Affairs (DYA), Guam
 9 Environmental Protection Agency (GEPA), Department of Labor (DOL),
 10 Department of Parks and Recreation (DPR), Department of Land Management
 11 (DLM), Office of the Chief Medical Examiner (CME), Customs and Quarantine
 12 Agency (CQA), Department of *Chamorro* Affairs (DCA), Department of Military
 13 Affairs (DMA), Guam Council on the Arts and Humanities Agency (CAHA),
 14 Guam Fire Department (GFD), Guam Educational Telecommunications
 15 Corporation (GETC), *Chamorro* Land Trust Commission (CLTC), Guam Regional
 16 Transit Authority (GRTA), and Guam Solid Waste Authority (GSWA), Office of
 17 Public Accountability (OPA), Office of the Attorney General (OAG), and Mayors'
 18 Council of Guam (MCOG).

19 This sum is composed of Four Million Eight Hundred Ninety Eight
 20 Thousand Four Hundred Ninety Two Dollars (**\$4,898,492**) from the General Fund
 21 and Eight Hundred Six Thousand Eighty Seven Dollars (**\$806,087**) from Special
 22 Funds.

19 (b) The sum of Five Million Eighty One Thousand Eight Hundred Eighty
20 Seven Dollars (**\$5,081,887**) is appropriated from the General Fund for
21 medical and dental insurance premiums for fiscal year ending September
22 30, 2014 for the Guam Department of Education.

23 (c) The sum of One Million Two Hundred Eighty One Thousand Eight
24 Hundred Sixty Five Dollars (**\$1,281,865**) is appropriated from the
25 General Fund for medical and dental insurance premiums for fiscal year
26 ending September 30, 2014 for the University of Guam.

1 (d) The sum of Four Hundred Seventy Five Thousand Nine Hundred Sixty
2 Seven Dollars (**\$475,967**) is appropriated from the General Fund for
3 medical and dental insurance premiums for fiscal year ending September
4 30, 2014 for the Guam Community College.

5 (e) The sum of One Hundred Two Thousand Fifty Eight Dollars (**\$102,058**)
6 is appropriated from the General Fund for medical and dental insurance
7 premiums for fiscal year ending September 30, 2014 for the Public
8 Defender Service Corporation.

9 (f) The sum of One Hundred Sixty Four Thousand Six Hundred Seventeen
10 Dollars (**\$164,617**) is appropriated from the General Fund for medical
11 and dental insurance premiums for fiscal year ending September 30, 2014
12 for *I Liheslaturan Guåhan*.

13 **Section 3. Retiree Medical and Dental Insurance Expenses**
14 **Appropriated to the Government of Guam Retirement Fund (GGRF).** The
15 sum of Sixteen Million Six Hundred Twenty Five Thousand Five Hundred Forty
16 Six Dollars (**\$16,625,546**) is appropriated from the General Fund to the GGRF to
17 pay for retiree group medical and dental insurance premiums to continue existing
18 programs currently contained in the semi-monthly payments.

19 **Section 4. Government of Guam Health Insurance Program**
20 **Reporting.**

21 (a) All health insurance carriers for the government of Guam *shall* submit
22 a monthly written report and corresponding Microsoft Excel file of said report to
23 the Department of Administration and the Office of Finance Budget aggregating
24 the:

25 (1) Enrollees, both subscribers and dependents, by active employee
26 and retiree subscriber counts by plan by class by groups supported/paid by
27 the General Fund, detailed by agency/department; and enrollees, both

1 subscribers and dependents, by active employee and retiree subscriber
2 counts by plan by class by groups supported/paid by autonomous agencies of
3 the government of Guam, detailed by autonomous agency.

4 (2) Autonomous agencies within this Subsection *shall* include the
5 Guam Power Authority, the Guam Waterworks Authority, the Jose D. Leon
6 Guerrero Commercial Port, the A.B. Won Pat International Airport
7 Authority, the Guam Housing Corporation, the Guam Economic
8 Development Authority, the Government of Guam Retirement Fund, and the
9 Guam Visitors Bureau.

10 (3) This report and corresponding Microsoft Excel file *shall* be
11 filed with *I Maga'låhen Guåhan* and the Speaker of *I Liheslaturan Guåhan*
12 *no later than* twenty (20) days after the end of each month of Fiscal Year
13 2014.

14 (b) All health insurance carriers for the government of Guam *shall* file a
15 monthly written report detailing each individual health insurance premium
16 payment received by the government of Guam health insurance carrier from the
17 government of Guam, by date and by agency to *I Liheslaturan Guåhan no later*
18 *than* twenty (20) days after the end of each month of Fiscal Year 2014.

19 **Section 5. Severability.** If any provision of this Act or its application to
20 any person or circumstance is held invalid, the invalidity *shall not* affect other
21 provisions or applications of this Act which can be given effect without the invalid
22 provision or application and to this end the provisions of this Act are severable.
