Dear Madam Speaker,

Attached is Bill No. 235 -32 (COR), *An act . . . relative to upholding the intent of I Liheslatura's annual appropriations to the Guam Department of Education (GDOE) for every Fiscal Year and for funding to address the deferred maintenance needs of the George Washington High School, the retrofitting of unused buildings and facilities at Southern High School for GDOE Central Offices, and for other facilities and maintenance needs of the GDOE, which I have vetoed.*

My administration has worked hard to manage the finances of the government in a responsible and prudent manner. At the same time, it has also worked towards prioritizing and providing for an adequate education to every public school student. Although Bill 235-32 purports to support GDOE, it actually accomplishes the *opposite* through its restrictions on the Governor's Organic Act authority to implement budget policies for the Executive Branch. It is an executive function to appropriate budgetary reserves in order to assure that projected revenues meet or exceed expenditures.

Restricting the amount of reserve authority does not solve the funding shortfall problems of GDOE. GDOE testified that over the course of FY2013, the entire amount of the 10% reserved from its appropriation was released to it. GDOE was able to operate and manage its budget without suffering from a premature shortfall as has been in the case in years past. Rather than attacking the amount of reserves set aside for GDOE, I urge *I Liheslatura* to consider assisting GDOE in identifying funding resources beyond the amounts in its current appropriation.






