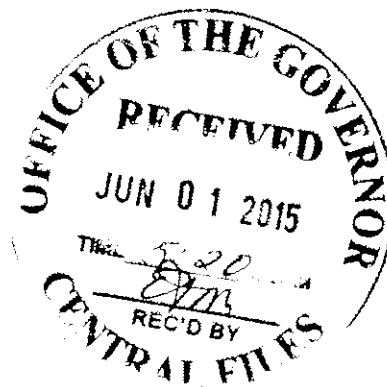
1. The Legislature did consent to the Executive Appointment of William M. Castro to serve as the Director of the Bureau of Statistics and Plans.


