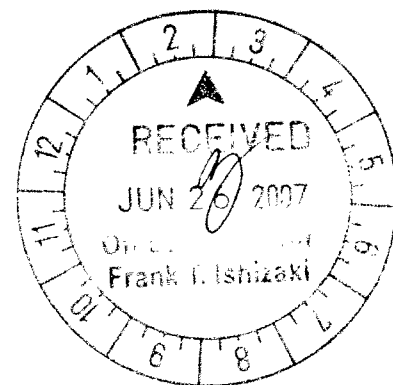

Earlier in this term, I introduced the following bills for consideration by the Legislature.

- 1) Bill 66: an act to repeal public law 28-150, chapter IV, part I, section 3 relative to reducing the fiscal year 2007 budget by twenty five million dollars;
- 2) Bill 79: an act to repeal provisions in Guam law authorizing the issuance of general obligation bonds; and
- 3) Bill 94: an act to amend 11GCA §26201 relative to gross receipts taxes.

I respectfully submit to the Committee on Calendar that the aforementioned bills now require no further Committee action.

During deliberations on Bill 74, the revised Fiscal Year 2007 budget bill, the above bills were incorporated as amendments.

I am therefore withdrawing the above referenced bills for further consideration and action by the Legislature.
